Join us for the Maryland \$4 for 4-H Annual Fundraising campaign sponsored by the Maryland 4-H Foundation!

This campaign is the largest fundraiser we participate in to raise funds to support the Carroll County 4-H Program. Of every donation made in the name of Carroll County 4-H, we receive 50% of those funds. It is a wonderful opportunity to link arms with other counties across the state to support the Maryland 4-H Foundation, all while supporting our own program here in the County.

In 2024, the Carroll County 4-H Program received \$2,326 (\$4,652 raised in total) from 136 generous donors, which was the highest number of donations that any other county/city received! The funds raised help us provide county wide programming for our 4-H members throughout the year.

2025 Enrollment

ALL 4-H Members, Clovers and UME Volunteers need to enroll for the 2025 4-H year. You will log into 4-H Online (v2.4honline.com) to complete your 2025 enrollment. Please note that EVERYONE (4-H MEMBERS, CLOVERS AND UME VOLUNTEERS) will need to log into their family accounts that you have already created and re-enroll each person listed on your account. DO NOT CREATE A NEW ACCOUNT – LOG IN USING YOUR EMAIL AND PASSWORD. If you have forgotten your password, there is an option to restore your password.

ALL 4-H MEMBERS AND CLOVERS MUST PAY THEIR \$10 STATE PARTICIPATION FEE THROUGH 4-H ONLINE. UME Volunteers do not pay a participation fee. The insurance fee that 4-H Members, Clovers and UME Volunteers pay will still be paid through your 4-H Club.

Remember, you must be enrolled in the Carroll County 4-H Program by May 1, 2025 to be eligible to show at the 2025 Carroll County 4-H/FFA Fair or to be recognized as a UME Volunteer. If you have any questions, please call the Extension Office at 410-386-2760. The sooner the better!

4-H Expectations

As you take time at the beginning of the year to work on your 4-H enrollment, please take a few minutes to review several forms and documents that you are signing when you enroll in 4-H or have voted on within your clubs. We've heard it's been awhile since some of our 4-H families have been seen at their local club meetings, families not receiving information, etc. Remember, everyone should be attending regular club meetings and reading all documents you sign!

Club Attendance – Each club has bylaws which are voted on by the membership. Many of these bylaws have attendance policies set in them which state that if a 4-Her misses 3 or more consecutive meetings, they may be removed from the club. This could lead to not being able to participate at the fair if you're not attending club meetings. Make sure to attend the monthly meetings as it's an important part of being a 4-Her, but also a great way to be involved and know what is happening within the program.

Youth Code of Conduct – This is a set of guidelines that outline the expectations of behavior at 4-H events. A copy has been attached to the online *Tribune* and we hope that families will take a few minutes to read through the Code of Conduct. This document is electronically signed by the 4-Her and the parent/guardian when they enroll online each year.

Project Related Consents/Ethics – As you also sign up for your individual projects in 4-H Online, take notice that there are consents that you are signing too. Most of these are related to animal science projects, but the shooting sports program also has additional consents that are signed.

Please take the time to review what you are signing and what the expectations are for being a member in 4-H.

Clover Age 4-Hers (5-7 years old) are invited to join members of the Ambassador Team to make Chocolate Chip Cookies and build their own brownie mix to be taken home and baked. Participants must be enrolled members of the Carroll County 4-H Program and must be between the ages of 5-7 years old. This class will be held on **Friday, April 25, 2025 at 6pm at the Extension Office. Class fee is \$5 and will be collected at the door**. **Class is FULL**. NEW PAYMENT POLICY

NEW POLICY in regards to payments for county 4-H programs. We will be sending invoices to those who register for our programs that cost over \$5. As we plan programs, we work on making sure we can cover the cost of the supplies of the program and keep program costs as low as possible. We have simply asked that families pay "at the door" for these programs. What we have been experiencing recently though is that some families are signing up for programs and then not attending without letting the office staff know of that change. We typically have 4-H members on a waiting list that would like to come to the program, but can't when we are unaware of someone not attending. Moving forward, if you register for a program that has a cost associated with it and do not show for the program, you are still responsible for paying for the program as supplies have already been purchased.

This is not a decision that we have made lightly. We do need to take into consideration the costs we are taking out of our program funds when individuals are a no call, no show for programs. We also need to consider the other 4-H members who would like to participate in the program, but are on a waiting list.

Market Swine Weigh-In

If you plan to exhibit Market Swine at the Carroll County 4-H & FFA Fair or Maryland State Fair, it must have a Maryland 4-H ear tag and be weighed in at the Carroll County 4-H Weigh-In. Market Swine Weigh-In will be held on Friday, May 2nd from 5-9pm at the Carroll County Ag Center (TRP Barn). You must turn in a completed 2-part Livestock Registration form to the Extension Office with the number of tags you will need. Livestock Registration Forms are due to the Extension Office by April 25th.

Remember to fill in ALL information, including RFID tag numbers. This helps us as your pigs come across the scales to match up to who owns the animal when there are multiple 4-Hers on one trailer. The Animal Science Code of Ethics will be on the reverse side and BOTH pages must be signed. There will be a total of 3 signatures for the 4-Her and 3 for the parent/guardian. Tags cost \$2. Checks can be made payable to CCEAB. You must register, tag and weigh-in the appropriate animal for Carroll County. You may not weigh-in your animals at another county and be eligible for the Carroll County 4-H/FFA Fair. Questions? Call 410-386-2760. This is the only weigh in date for swine for Carroll County 4-H members!

Castration Policy of the Maryland 4-H AnSc Program: All male steers, lambs, pigs and goats must be neutered and healed prior to 4-H weigh-in and tagging. The only exception would be animals that have obvious signs they have been banded, however, their scrotal sac is still intact.

Market Goat and Market Lamb Weigh-In/Commercial Goat-Lamb Tagging

If you plan to exhibit a Market Goat or Market Lamb at the Carroll County 4-H & FFA Fair or Maryland State Fair, it must have a Maryland 4-H ear tag and be weighed in at the Carroll County 4-H Weigh-In. Market Goat and Market Lamb Weigh-In will be held on Friday, May 16th from 5-8pm at the Carroll County Ag Center (TRP Barn). You must turn in a completed 2-part Livestock Registration form to the Extension Office with the number of tags you will need. If you are planning to show a market animal and a commercial breeding animal, they MUST be on 2 separate Livestock Registration Forms. Livestock Registration Forms are due to the Extension Office by May 9th. Remember to fill in ALL information, including Scrapie tag numbers. Having ALL information filled in helps the committees move through weigh-in quicker and helps match up animals when multiple 4-H members are on the same trailer. The Animal Science Code of Ethics will be on the reverse side and BOTH pages must be signed. There will be a total of 3 signatures for the 4-Her and 3 for the parent/guardian. Tags cost \$2. Checks can be made payable to CCEAB. You must register, tag and weigh-in the appropriate animal for Carroll County. You may not weigh-in your animals at another county and be eligible for the Carroll County 4-H/FFA Fair. Questions? Call 410-386-2760. This is the only weigh in date for Market Goats and Lambs for Carroll County 4-H members!

Castration Policy of the Maryland 4-H AnSc Program: All male steers, lambs, pigs and goats must be neutered and healed prior to 4-H weigh-in and tagging. The only exception would be animals that have obvious signs they have been banded, however, their scrotal sac is still intact.

Market Livestock Updates

Make sure to read through all of the livestock department and livestock sale rules, but here are some changes for 2025 that we wanted to make sure our 4-H families are aware of...

Market Beef/Dairy Steers — There will be no Rate of Gain (ROG) for 2025. Market Beef/Dairy Steers still need to meet weight requirements and grade per the livestock sale rules.

Market Goat Updates—A change to the Market Goat requirements is that the minimum weight is now 65 lbs. for 2025. There will also be a limit of 3 market goats per exhibitor to be shown at the 2025 fair.

Market Swine - Rate of Gain has been lowered from 1.6 lbs. to 1.4 lbs. for 2025, which matches the ROG for the Maryland State Fair.

Market Lamb Classes—There are a couple of changes to the Market Lamb show at the 2025 Carroll County 4-H & FFA Fair. The first is that there will be no Rate of Gain. Lambs still need to meet weight requirements. There will also be a limit of 3 market lambs per exhibitor. New this year for the market lamb show, lambs will be classified into 4 "classification divisions".

MARKET LAMB CLASSIFICATION STANDARDS These are the recognized classifications for the Carroll County 4-H & FFA Fair Market Lamb Show. Lambs must meet all classification standards as established by the Fair. No pedigrees will be required.

Natural Colored: 1. Must have a predominant "blue or black tint" to the skin and wool **2**. A few black or blue spots coloring of the wool, bite marks, fungus spots or scars with black or dark fiber areas will not classify a lamb in this division.


White Face Crossbred: 1. Must be white-faced, brockle-faced or show evidence of at least 50% white face or more throughout the face and ears 2. Reddish rust-colored legs are acceptable.

Black Face Crossbred: This class generally includes the Suffolk and Hampshire breeds, plus all lambs that do not fit into the Natural or White Face Crossbred divisions.

AOB: If a lamb shows breed characteristics of a breed other than those listed above, it will be added to the AOB division. Lamb must show obvious breed characteristics.

Lambs will be checked by a classification committee after weigh-ins during the fair. If a lamb is entered in a classification but does not pass, it will be moved to the Black Face Crossbred classification.

For all market livestock shows, there will no longer be any exhibition classes. If your market animal does not meet livestock sale requirements, you will be able to show the animal in a showmanship class, but there will no longer be exhibition market classes. More information on these changes and anything else will be discussed at the respective livestock workshops. Make plans to attend those workshops to learn more and ask your questions.



Swine Workshop

Hold the date! The Swine Workshop will be held on **Sunday, April 6th at 1pm at the Extension Office**. Hands-on stations relating to swine topics will be presented, along with an informational session for parents/guardians. All juniors (8-10 years old) and novice (1st year exhibitors) must attend at least 1 livestock workshop to meet the CC 4-H & FFA Livestock Sale rules. It's highly encouraged that you attend the workshop related to the species you are showing. Make sure to **register by March 28th** to ensure we have enough supplies for everyone. Beef Field Day

Sheep Workshop

The 2025 Sheep Workshop is scheduled for Sunday, April 13, 2025 at 1pm. NEW LOCATION! New information will be shared as the committee is trying some new classes this year. Hands-on sessions are also being worked on for 4-Hers to learn more about their sheep project. Remember, ALL Juniors and Novice exhibitors must attend at least one workshop to meet the livestock sale requirements. It's highly recommended that you attend the workshops for the species you are showing. Make sure to register by April 4th to ensure we have enough supplies for everyone. All juniors (8-10 years old) and novice (1st year exhibitors) must attend at least 1 livestock workshop to meet the CC 4-H & FFA Livestock Sale rules. 2025 Poultry Orientation

Poultry Exhibitors: If you are planning to OR thinking about showing anything in the Poultry Department at the Carroll County 4-H & FFA Fair in 2025, you are REQUIRED to attend ONE of the orientation meetings. This includes poultry, turkey, posters, eggs, clovers, etc. This also includes first year and returning exhibitors. These meetings are for the Poultry Department and do not meet any requirements for any other livestock department. The meetings are in person (no virtual meeting offered and no make up sessions offered). All meetings are at the Extension Office and begin at 7 p.m.—check the listing on the board for the room number.

There are 2 options left to attend 1 meeting:

Wednesday, April 2nd

Tuesday, May 20th

Again, you need to attend only ONE of the meetings.

Reminder: If you showed in the Poultry Department in 2024, you are required to have completed a Poultry Project Record Sheet in order to show in 2025, so be sure you have completed that (Clovers are exempt). Any questions, call or text Nancy Carlisle at 443-605-5134.

Dairy Bowl Practices

Dairy Bowl practices have started again! Remember, anyone who has an interest in learning more about the dairy industry can attend these practices. Horse Safety Class

If you are a 1st year Horse Exhibitor, you are required to attend one of the horse safety classes offered to exhibit at the 2025 Carroll County 4-H & FFA Fair. Exhibitors will learn about horse safety, along with an orientation about what happens on show day at the fair and what you need to bring. If you haven't already attended one of the meetings, you must attend the last meeting on May 12th at 7pm at the Extension Office.

Sheep, Goat and Swine 4-H Classic Shows

We are excited to hold the Carroll 4-H Sheep and Goat Classic and the Carroll 4-H Swine Classic Shows this year in Carroll County. These were formally shows that we held in partnership with Howard County, but have moved back to a county focus on these opportunities!

We will be hosting both of these spring livestock shows at the Carroll County Ag Center this summer. We will be down in the Gesell Parking Lot showing under a tent. Red Building Updates – Spring is here so it's time to think of flowers and vegetables to be planted. Check out the February 2025 Tribune for new classes being added in the Garden Department.

The **Natural Resource Department** will have a class for Clovers—Wildlife Insects. This class is strictly for Clovers and will be entered in the Natural Resource Department during their entry time. All other Clover exhibits will be entered in the Clover Department.

The **Photography Department** has no new classes but has changes or clarifications to rules. These rules will be found on the Carroll County 4-H & FFA Fair website under Forms & Docs and then go to the Photography Department.

A new change in the **Craft Department** will be drop and go entries. The superintendents of the department are recommending that the 4-Her attach a 3x5" card to each craft exhibit to explain the item and the steps involved for the judges.

Fair Premiums are not guaranteed for projects entered at the fair. Each year, fair premiums are offset by funds received by the Maryland Agricultural Fair Board. The CC 4-H & FFA Fair Board is concerned that the amount of funding they've received previously may be drastically cut. That's why you will see information about the fundraisers the CC 4-H & FFA Fair Board is holding. Indoor exhibitors can assist with lowering costs for the fair too. When making entries, be realistic with your entries. For example, there are 70 plus classes in the Craft Department at the 2025 Carroll County 4-H & FFA Fair. We would love for 4-Hers to enter all these classes, but the reality is there probably isn't enough time to complete entries for all 70 classes. You may not be interested in entering in some of these classes. Try to only make entries for classes that you can complete your projects in. This will assist the fair in saving money that is spent to print entry tags that could be used towards your premiums. There is a simple substitution system within the indoor departments. You no longer need a new entry tag printed. For example, you can take an entry tag in crafts and just change the class number and name of the new craft class and attach to your exhibit. You can only do substitutions within the same department with a tag you may not be using. - Sandra Stonesifer, Indoor Superintendent

Fair Horse Department Fundraiser—The Horse Committee is raffling a 75" TV. Dear Carroll County 4-H & FFA Beef Exhibitors:

The 2025 Beef Field Day will have a new look for 2025. We will be coming back to Carroll County and holding the field day just for Carroll County 4-H & FFA members. We still are planning to have a great event for our members and their families to attend on **Saturday, April 12, 2025 at the Carroll County Ag Center in the TRP Barn.** We hope to see many of you come out to the show! As a reminder, if you are a junior or novice exhibitor you must attend at least 1 livestock workshop to meet the sale requirements. Participating in beef field day would count as a livestock workshop. If you cannot attend the field day, please note that the Beef Workshop will be held on Sunday, February 4th at 1pm at the Extension Office.

Please read the important information below concerning Beef Field Day.

- This will be a primarily show off trailer event. Limited stalls will be set up but are being held for our novice and junior members. Please make sure to check the box on the entry form if you are a new family and would like to stall inside of the barn.
- For 2025 we will be limiting each member to showing 2 total animals.
- Please be sure to list 4-H tag number on the entry form for each steer, commercial heifer or market heifer you are entering. Make sure to include all information on purebred heifers (registration number, birth date, etc.).
- We will follow all Carroll County 4-H & FFA Fair Beef and Dairy Steer Department Rules for the show. Classes will be the same as listed in the beef department rules. Breeds for all shows will be broken based on numbers the day of the show.
- There will be no wash racks open for the field day. Plan to have your animals clipped and washed before arriving.
- There will be a \$15.00 entry fee per child for the Carroll 4-H Beef Field Day. This is to offset the cost of the judge, awards and other expenses. Please make checks payable to Carroll County 4-H/FFA Fair and write in the memo line: 4-H Beef Field Day.
- <u>ALL ENTRIES NEED TO BE POSTMARKED BY APRIL 4, 2025.</u> Late entries will be accepted until **April 10, 2025**. If you have a late entry you will need to pay \$10.00 per head to enter in addition to the \$15.00 per child fee.
- Please remember the guidelines concerning health papers. You must have your health papers for Beef Field Day & they will be checked. Please remember CVI/Health Forms are only good for 120 days. Please be sure to read the Maryland Department of Agriculture (MDA) guidelines regarding RFID tag requirements for cattle in 2025. You will also need to bring your health papers for your cattle. Please be sure to look at your animals and fill out the back of the health papers (self-certification) & sign them before you come to the show.
- Please do not bring any animals with ringworm or warts.

- Heifers Commercial heifers, meaning they cannot be registered with a breed association the heifer must be tagged with a green 4-H ear tag. For heifers that can be registered, they must be tattooed & you must bring their registration papers. The tattoos need to be clean, clear, & legible.
- Remember all steers have to be registered & tattooed in order to show in the purebred divisions, otherwise they will be shown with the crossbreds. Bring your steer registration papers to the scales for them to be checked. Additionally, make sure your purebred animals are tattooed, and the ear has been cleaned so the tattoo can be read.
- This is a **NO FIT SHOW** like at the fair so you will not need any fitting supplies! Animals are to be washed and dried only.
- You <u>MUST</u> take your bedding home after the show, please bring a wheelbarrow. We do not have a way of
 disposing of any bedding or waste after the show.
- If showing off your trailer you MUST clean up your area prior to leaving. You are responsible for any electricity you may need. Generators are allowed at trailers.
- There will be other activities going on at the fairgrounds that day, so please remember to be respectful of others. Park in the designated areas.
- After the show, please remember to make sure to clean up all areas and all help is appreciated to clean up the barn/show ring.
- Any additional information about the Beef Field Day will be emailed to families closer to the event.

University of Maryland Extension (UME) 4-H Code of Animal Science Ethics

4-H members enrolled in animal science projects (*e.g.*, beef, camelids, dairy, dog, goat, horse, poultry, rabbit, sheep, small pet, and swine) shall, at all times, conduct themselves with honesty and good sportsmanship, including while with their projects and at all 4-H animal science activities and events. Their conduct should always reflect the highest standards of honor and dignity to promote the advancement of 4-H and its animal science program. 4-H members, as well as parents, UME volunteers and others working with them, are under an affirmative responsibility to do more than avoid improper conduct or questionable acts; and their conduct and values must serve as a positive influence on others.

This Code of Ethics applies to all 4-H members who are enrolled in animal science projects, and to others (4-Hers, parents, volunteers, owners, etc.) who participate in the animal science program; and it covers daily animal care, as well as participation in competition and other 4-H animal activities and events.

4-H members and others who violate this Code of Ethics demean the integrity of 4-H and its animal science program. 4-H members who violate the code of animal science ethics are subject to sanctions including, but not limited to, forfeiture of premiums, awards, and/or auction proceeds and may be prohibited from participation in 4-H or 4-H/UME events or activities; other violators may also be subject to sanction, as appropriate. Infractions may be reviewed by 4-H and/or UME (on the local or state level, as appropriate to the infraction and to the event and/or activity in question), and/or may be subject to a fair oversight committee or other entity that oversees an activity or event. In addition, some acts may also be subject to review based upon the *Maryland 4-H Youth Code of Conduct* and/or other UME policies.

The following is a list of standards and requirements for all 4-H animal science projects, at all times, whether at home, at animal exhibitions or events, or any other 4-H event or activity.

- 1. The care of all 4-H project animals is the responsibility of the 4-H member. 4-H members must properly care for and groom their animals for the duration of their project.
- 2. All project animals must be housed at the 4-H member's residence unless a different location is submitted to and approved in writing by the local 4-H staff. Any change in location must be approved in writing by the local 4-H staff; however, it is not necessary to report direct transport to and from shows or other events.
- 3. Upon request of 4-H, UME, or other program, fair, event or animal officials, 4-H members must present proof of ownership, length of ownership, identity and/or age of all 4-H project animals owned or leased. Misrepresentation of ownership, age, or identity of animal, or any facts relating thereto is prohibited. If a 4-H project animal is sold in a livestock sale, it is no longer eligible to be shown in a 4-H event in Maryland in that year.
- 4. 4-H members must provide appropriate animal health certificates upon request of 4-H, UME, or other program, fair, event or animal officials.
- 5. 4-H project animals must be presented to competition, activities and/or events, where they will enter the food chain, free of volatile drug residues. Animals which are presented to competition, events and/or activities that do not culminate with the animal entering the food chain, shall not be administered drugs other than in accordance with applicable federal, state, and local laws, regulations and rules. 4-H project animals shall not be exhibited if drugs administered in accordance with federal, state, and local regulations and rules may affect the animal's performance or appearance at the event. At any time after an animal arrives on a fair or other 4-H activity or event premises, a licensed veterinarian must administer or, in consultation with fair, event, UME, or 4-H officials, direct the administration of any treatments involving the use of drugs and/or medications. Drenching at any time after an animal arrives on a fair or other 4-H activity or event premises is prohibited, except when performed or directed by a licensed veterinarian in consultation with fair, event, UME, or 4-H officials for the sole purpose of protecting the health of the animal.

 6. The act of enrolling in a 4-H animal science project, and/or entering a project animal in a 4-H competition, show, activity, or other event, gives consent for 4-H or UME or event authorities to obtain any specimens of urine, saliva, blood, hair, tissue, or other substance from the animal to be used for testing purposes including, but not limited to, drugs or identification. It is presumed that the sample of urine, saliva, blood or other substance tested by the approved laboratory to which it is sent is the one taken from the animal in question, its integrity is preserved, and all procedures of said collection and preservation, transfer to the laboratory pertains to the sample analysis of the sample was taken, with the burden on the 4-H owner to prove otherwise at any review in regard to the matter conducted by a fair or other event or the 4-H program. I
- indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally.

 7. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counter irritant, or similar substance) which could affect the animal's performance or alter its natural contour, conformation, or appearance, except external applications of substances to the hoofs or horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
- 8. Using ice, ice packs, cold packs, or cold compresses, internally or externally, other than those prescribed to relieve heat stress or a medical condition as diagnosed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
- 9. The use of showing and/or handling practices or devices, such as striking animals to cause swelling, using electrical devices, or other similar practices, are not acceptable and are prohibited.
- 10. All judges, fair and event officials and/or UME/4-H staff and volunteers shall be treated with courtesy, cooperation, and respect, and no person shall direct abusive or threatening conduct toward them or toward exhibitors or others participating in the activity. In addition, direct criticism or interference with a judge, fair, show or event official, exhibitor, breed representative, or UME/4-H staff or volunteer before, during, or after an event or other activity is prohibited.
- 11. No one shall violate this Code of Animal Science Ethics or conspire with another person or persons to intentionally violate this Code of Ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this Code of Ethics.
- 12. The application of this Code of Ethics provides for absolute responsibility for an animal's condition to the 4-H member whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this Code of Ethics.
- 13. By enrolling in an animal science project and/or entering an animal in a fair or other 4-H event or activity, the 4-H member, and his/her parent or guardian, consent to have disciplinary action taken by appropriate authorities (including UME, 4-H, fair, event and/or other activity officials) for violation of this Code of Animal Science Ethics and/or any other applicable rules of UME, 4-H, a fair, activity or other event, without recourse against UME, 4-H and/or other authorities. In addition, the 4-H member, and his/her parent or guardian, further understand and agree that any action which contravenes these rules, and is also in violation of federal, state, or local laws, statutes, regulations, or rules, may be released to appropriate law enforcement authorities with jurisdiction over such infractions.

By signing this form the 4-H member and his/her parent or guardian each verify that they have read and understand the UME 4-H Code of Animal Science Ethics and the consequences of and penalties provided for violations of the Code.
