# Tawes Garden

Autumn has come to Tawes Garden and our team had its final scheduled workday the last week of October. For the next few months, MG's are still welcome to work in the garden but would need to coordinate their schedule with Suzanne Weber, Tawes Horticulturist. She would be happy to have help anytime.

We've had a great season, have gotten a great deal accomplished in the garden and have continued our mission to promote native plants and pollinator-friendly habitats. Our major accomplishment in October was the completion of Phase IV of our Unity Gardensfunded project to transition the Plant Mural to native plants. This year, we focused on removing a large swath of invasive plants and non-native grasses, replacing them with native switchgrass, bunny blue carex and Joe Pye weed. Once the switchgrass fills in, this year's efforts will provide a striking first impression to anyone visiting the Plant Mural. It already looks pretty good! Thank you to all those who helped move



this effort along - it wouldn't have happened without the ideas, time and muscle of many MG's.

Our biggest challenge this fall has been that shared by everyone – the drought. We've had to devote more time than usual to watering – even native plants cannot survive without some help. Having said that, the choice of natives has enabled the garden to continue to look pretty good, with a variety of colors, textures and fall blooms which contribute to a very interesting plant "mural". Tawes Garden does have its share of deer and they have munched a number of new and old perennials but haven't decimated the garden.

Because Tawes Garden is also an official Maryland State Park and Arboretum, fall is a particularly beautiful time of year with many mature trees in shades of gold, red and orange. If anyone is in the Annapolis area, there is free parking in front of the DNR building and the garden is open to the public. It is definitely worth a visit.

Thank you again to all the Tawes volunteers who showed up this year. We are very grateful to all of you and hope to see you in the spring.





# **Apprentice Gardens - Kinder Farm Park**

#### Educational Outreach Activities (upcoming, monthly)

• During October, a few of the Apprentice Garden families tended their summer crops that continued to produce and their fall crops.

#### Volunteer Opportunities (upcoming, monthly)



• Occasional work parties were scheduled to complete the closing of the garden, including clearing debris, planting cover crop, cleaning and storing tools, and refreshing straw on the pathways.

#### Accomplishments and Challenges

By the end of October all the Apprentice Garden family spaces were cleared of debris, and crimson clover cover crop has been planted in those spaces, and the common areas. Perennial herbs from the Mediterranean garden, including rosemary, sage, lavender, thyme and chives continue to grow well and will overwinter in place.

The strawberry patch (and black-eyed Susan border) and the perennial flower gardens both inside and outside along the fence have been weeded and cleared of most of the debris. Some seed heads will be left for the birds during the fall and winter. The fruit on the passion flower vine has continued to ripen. Thank you's to Kristin Silva, Kathy Albers, Wendy Boardman, Kathy Enderle, Deb Fritz, and Lourdes Hergenroeder for their participation in the October work parties. The gardens look wonderful!

All of the families who are eligible to join the Apprentice Garden for a second year, are interested in joining us next season.

# **Re-Pollinate Anne Arundel**

On Halloween, RePollinate had the pleasure of hosting Dr. Small-Lorenz and Maxine Yoon. From our discussions it sounds like RePollinate is only going to get better.

Wild Ones Chesapeake Bay participated in native plant propagation at the USGS Bee Lab this year, growing over 2000 native



plants. We are pleased to announce that we are partnering with RePollinate Anne Arundel 2024 to distribute native plants to residents in our region. (Residence in Anne Arundel Count is not required.)

RePollinate AACO offers native plants to support native habitat and restoration projects. A modest donation to support future plant propagation at the Bee Lab is suggested. Pickup is at the USGS Patuxent Research Center Wild Bee Lab on Thursdays from 3-4 PM and Saturdays from 10 AM-1:30PM.


