LIABILITY RELEASE AND INFORMED CONSENT AGREEMENT

I wish/my child wishes to participate as a part of the University of Maryland (UME) Maryland 4-H Youth Development Program in all activities associated with the above-named Event. In connection with and consideration of participation in the Event, I, on behalf of my child and/or myself, my heirs, personal representative(s) and assigns, hereby represent and agree as follows:

- 1. I am aware that any program activity can be dangerous, and I fully recognize and understand that there are risks and hazards, both minor and serious, associated with participation in the Event and related activities. These risks and hazards include but are not limited to: cuts, scrapes, bruises, broken bones, muscle strains, pulls or tears, head, neck, back, eye and other bodily injuries, heat prostration, brain damage, blindness, deafness, drowning, heart attacks, paralysis and death. As with any activity, there are other inherent and/or unforeseen risks and hazards associated with the Event and related activities that cannot be predicted. I also understand that risks and hazards associated with the Event may arise in various contexts including but not limited to the following:

Spaces assigned for personal use at this event, such as sleeping quarters, lockers, etc. are under 4-H control at all times and are also subject to search as described above. Search of property/space owned, possessed, or occupied by an adult will be conducted by law enforcement personnel, if necessary. Law enforcement personnel may always conduct lawful searches for law enforcement purposes.

Beginner Cake Decorating: Basics of cake decorating will be taught-prepare a cake for decorating, learn to color frosting and how to choose decorator bags and tips. Practice basic techniques and decorate your own cake. (This class requires a **double session A&B**). Class limited to 10. *Taught by Theresa Lilienthal* 1 Double Class 10:00-11:45 am

Advanced Cake Decorating: Turn your cake into something special! Practice more techniques of cake decorating. Explore other types of materials– gum paste, color flow, etc. and decorate your own cake. (This class requires a **double session C&D**). Class limited to 10. *Taught by Theresa Lilienthal* 1 Double Class 12:30-2:15 pm

Introduction to Welding: Learn the basics of welding, how it works and the different equipment used. Then try your hand at striking your own arc! Long sleeves, pants and closed toe shoes are required. Dress for the weather, some time will be spent outside. Class is limited to 3. *Taught by Adam and Sam Wilson*

Introduction to Knitting: Learn the basic skills of knitting. This class will include the concepts of casting on, garter stitch and binding off. Participants will use these concepts to create a washcloth that can be entered in the Farm Fair. (This class requires a **double session A & B**). Class is limited to 5. *Taught by Jennifer Nance*

Introduction to Crocheting: Learn the basics skills of crocheting. This class will cover the concepts of creating a chain, single crochet and finishing. Participants will use these techniques to make a washcloth that can be entered in the Farm Fair. (This class requires a **double session C & D**). Class is limited to 5. *Taught by Jennifer Nance*

<u>Slime Time:</u> Have fun learning how to make slime! Class is limited to 8 participants. *Taught by Natalie McCann, Jane Sekowski, Ellie Cochran and Ashley Kirk*

Bejeweled Sunglasses: Craft a sparkly pair of fun sunglasses! Class limited to 8. Taught by Sam Johnson, Mia Cochran, Eva Fitzgerald and Braydon Cantos

Sand Art: Get ready to be creative! Participants will learn to layer sand in a container in order to make a 3D art project. Class limited to 8. *Taught by Lilah Fodel, Savi Baker, Lia and Kate Gervasi*

Wood Turning Demonstration: (double session, A&B or C&D) Great introduction to wood turning! Learn about safety, and view a variety of turned items. Watch adult demonstrators use the lathe to create wood pens. All participants will be invited to an upcoming workshop to complete their wood pen! **Participants must be at least 4 feet tall to use the equipment.** Class limited to 6. *Taught by Eric Crum and Barry Woolf– Baltimore Area Turners*

<u>Needlecraft:</u> Learn the basics of needlepoint! Begin a project by learning simple techniques. Class is limited to 5. *Taught by Janine Ortt*

Fairy Gardens: Participants will design and plant their own mystical miniature dish garden. They will receive two foliage plants and design a mini garden. Special garden features can be created from natural materials in our supply box. Gravel will be provided for garden paths, a pond or stream and students can make a miniature house or bridge from provided sticks. **Participants MUST bring a planter bowl or basin which is 4-6 inches deep and preferably 12-18 inches wide .** No one will be admitted to class without their bowl or basin. Soil, stones, plants, and craft material will be provided. Class limited to 6. *Taught by Joyce Browning*

<u>Diving Squid Toy</u>: Create a fun, diving toy that uses water pressure to make it dive! <u>PLEASE</u> <u>BRING A CLEAR, CLEAN 2 LITER BOTTLE</u> for this activity! Class limited to 5. *Taught by Laura Grace Muir*

Building Challenge: Test your engineering skills by creating attempting to construct the tallest tower, drop an egg without cracking and other fun challenges! Class limited to 8. *Elijah Sekowski*
